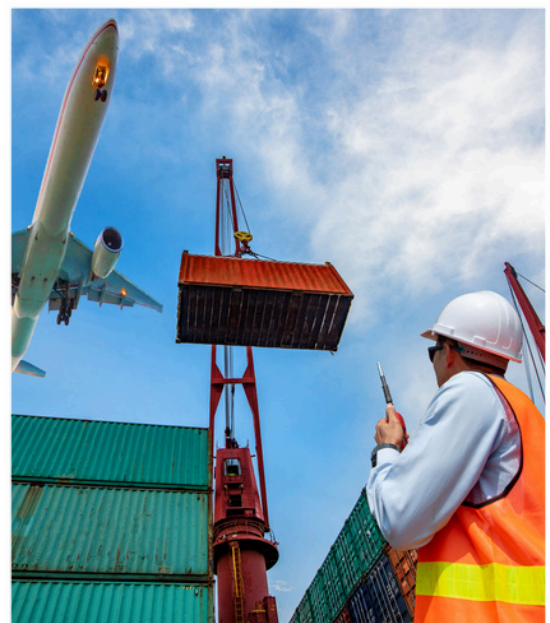

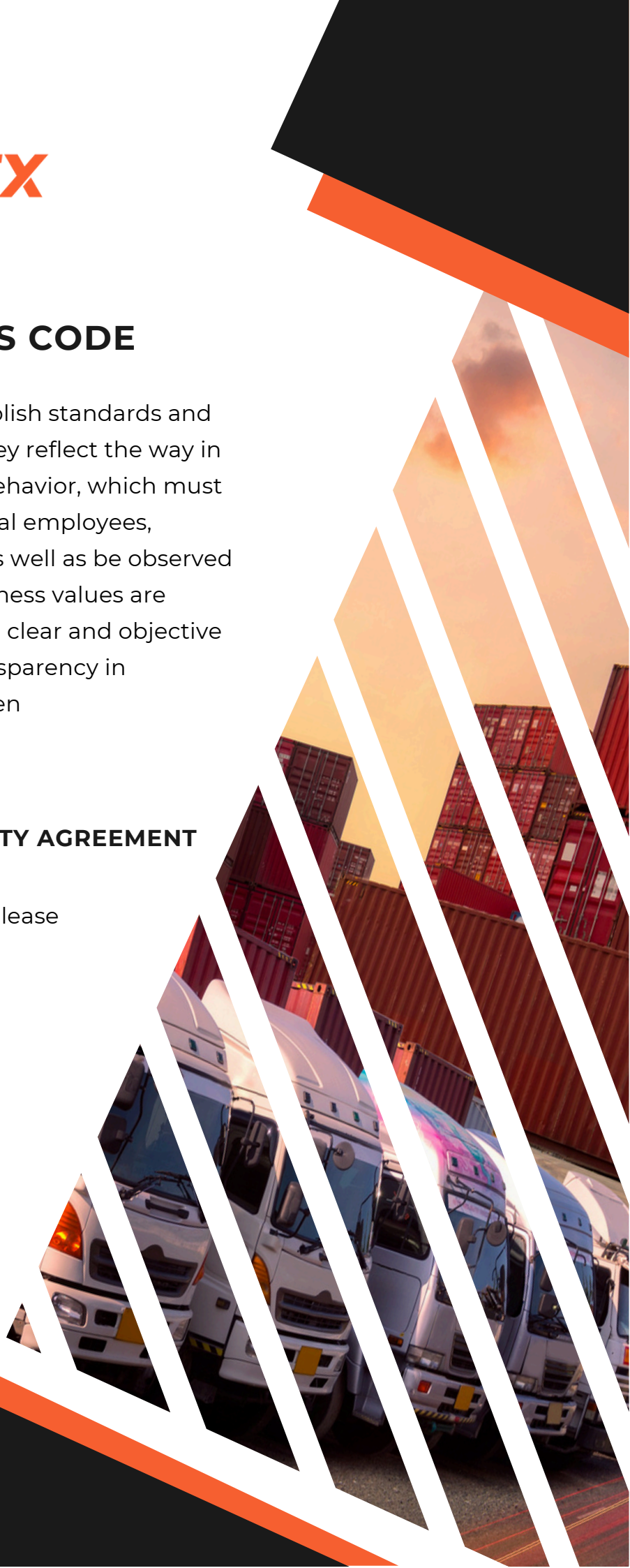


COMPLIANCE: ETHICS CODE
